

Terms & Conditions for Gemilang Lucky Draw Campaign

By joining this Campaign, you ("you", "your" or "customer") agree that you have read, understood and agreed to be bound by the Terms and Conditions of this Campaign and by any change or modification that we may make to this Campaign and/or the Terms and Conditions of this Campaign with prior notice to you. 1. Campaign Period

1 September 2026 to 30 September 2026, both dates inclusive ("Campaign Period").

2. Eligible Product

3. Campaign Mechanism

- 3.1. Under the Campaign, customers who successfully sign up for an Eligible Product during the Campaign Period and fulfil the Campaign requirements will be entitled to entries into the bi-weekly Lucky Draw ("Lucky Draw"). For each Lucky Draw, the policy/certificate must be activated prior to the draw date for the customer to be eligible for Lucky Draw.
- 3.2. To qualify for the Lucky Draw, a customer must have:
 - 3.2.1 a minimum annualised premium/contribution ("ANP/ANC") of RM2,400.
 - 3.2.2 be an AIA Vitality member (except for AIA Infinite Prosperity customers); and

- 3.2.3 complete the 'About You' Assessment via the AIA+ mobile application prior to the draw.
- 3.3. The calculation of the minimum ANP/ANC to be entitled for the Lucky Draw shall include premiums / contributions for A-Plus Saver, A-Plus Saver-i, A-Plus Enhancer-i, A-Plus Legasi Enhancer, A-Plus Infinite Enhancer Contribution and any Eligible Riders. AIA Vitality membership fees shall be excluded.
- 3.4. Eligible entries into the Lucky Draw will be allocated based on the ANP/ANC of each Eligible Product successfully activated, as follows:
- **New Customers:** One (1) Lucky Draw entry for every RM2,400 of ANP/ANC per policy/certificate.
 - **Existing Customers:** Two (2) Lucky Draw entries for every RM2,400 of ANP/ANC per policy/certificate.
- Note: AIA Infinite Prosperity, where the premium is denominated in USD/SGD, the premium will first be converted to MYR using the following fixed exchange rates for the purpose of calculating Lucky Draw entries: USD 1= RM4.00 and SGD 1 = RM3.03.
- A maximum of fifty (50) Lucky Draw entries per customer.
- 3.5. For the purpose of this Campaign, an Existing Customer ("Existing Customer") is defined as follows:
- A policy owner/certificate owner/insured/person covered of an in-force Conventional Individual Life product from AIA Bhd. or Takaful product from AIA PUBLIC Takaful Bhd. or Personal Accident (PA) insurance with AIA General Berhad, as at 31 August 2026;
 - A corporate policy owner/certificate owner of an in-force Conventional Group Employee Benefits Scheme from AIA Bhd. or Takaful Group Employee Benefits Scheme from AIA PUBLIC Takaful Bhd., or Group Personal Accident (PA) insurance with AIA General Berhad; or
 - An employee/member covered under Group Employee Benefits Scheme with an in-force Conventional Group Employee Benefits Scheme from AIA Bhd. or Takaful Group Employee Benefits Scheme from AIA PUBLIC Takaful Bhd., or Group Personal Accident (PA) insurance with AIA General Berhad.

4. Lucky Draw

4.1. Lucky Draw Prizes:

4.2. There will be two (2) rounds of Lucky Draw.

- The first draw will be held on 21 September 2026 for Eligible Customers who meet the Campaign criteria and submit their application under this Campaign

from 1 September 2026 to 15 September 2026, with the policy/certificate set in-force by 20 September 2026.

- The second draw will be held on 5 October 2026 for Eligible Customers who meet the Campaign criteria and submit their application under this Campaign from 1 September to 30 September 2026. with the policy/certificate set in-force by 4 October 2026. This second draw will exclude Winners from the first draw.

Note: Each Eligible Customer shall be entitled to win one (1) Lucky Draw Prize only during the entire duration of the Campaign.

- 4.3. The Lucky Draw will be conducted using a randomisation program and will be conducted under AIA's supervision. Potential Winners will be contacted by AIA via WhatsApp (Mobile Number: +6016-852-1256). To claim the Lucky Draw Prize, Potential Winners must correctly answer the question provided and respond via WhatsApp within forty-eight (48) hours from the message is sent ("Winners") by AIA, as recorded in AIA's system. The first response received will be the only response recorded.
- 4.4. Winners will be notified via email address registered with AIA and/or AIA's designated WhatsApp number (Mobile Number: +6016-852-1256) within three (3) workings days from the time they answered question stated in item 4.3. The list of Winners will also be published on AIA's official website and shared through AIA's official social media accounts.
- 4.5. If the Potential Winners fails to respond within the stipulated timeframe or provides an incorrect answer, the Potential Winners will be disqualified and deemed ineligible to claim the Lucky Draw Prize.
- 4.6. **Winners of the Proton e.MAS 5 (Premium):**
 - (a) Winners of the Lucky Draw Prize will be contacted by AIA as specified in Item 4.4 and provided with the relevant steps for the collection of the Lucky Draw Prize.
 - (b) To claim the Lucky Draw Prize, the Winners are required to register the vehicle with Jabatan Pengangkutan Jalan (JPJ) before redeeming the vehicle at his/her own costs and expenses.

 - (e) In the event the dealer is unable to supply the same model of the Lucky Draw Prize as described herein to AIA due to any reasons which include, but are not limited to manufacturer's recall or damage, force majeure, lost or stolen during storage and/or delivery, AIA reserves the right to substitute the Lucky Draw Prize with another model of like or similar value at its discretion with prior

notice of at least twenty one (21) calendar days before announcement of Lucky Draw Prize Winners. However, AIA bears no responsibility to replace the Lucky Draw Prize when it is damaged or stolen after delivery to the Lucky Draw Prize Winners.

4.7. Winners of the 20g Gold - (999.9 gold):

- (f) For Lucky Draw Prize fulfilment, the Winners are advised to regularly check the AIA+ app.
- (g) The fulfilment of the Lucky Draw Prize will be done within six to eight (6-8) weeks after the Campaign period ends.
- (h) Upon receiving email and/or WhatsApp regarding the entitlement to the Lucky Draw, the Winners shall submit the required fulfilment details via AIA+ app within the stipulated deadline.
- (i) Failure to provide the required details within specified timeframe shall result in forfeiture of the Lucky Draw Prize.

The voucher codes are not exchangeable for cash or any other gifts or voucher types. No appeals on this matter will be entertained.

Voucher Partners, which may include but is not limited to a redemption deadline for the services, blackout dates, and others. All the terms and conditions as specified by the AIA Voucher Partners for the voucher redemption shall apply.

4.9. Winners of RM500 into AIA+ Wallet:

 - (b) The fulfilment of the Lucky Draw Prize will be done within six to eight (6-8) weeks after the Campaign period ends into Winners' AIA+ wallet
- 4.10.  - Premium payments for the Eligible Product is not up to date;
 - Eligible Product has lapsed and subsequently reinstated; or
