

**SCORE WITH SPURS 2023  
JUNIOR FOOTBALL CAMP  
18 NOVEMBER 2023  
Terms and Conditions**

**1. The Event**

- i. SCORE WITH SPURS 2023 ("Event") is an on-ground football coaching programme organised by AIA Malaysia ("Organiser"). This Event will be held on Saturday, 18 November 2023 at Radia Arena, Shah Alam.
- ii. The coaching session is a half-day session. Selected participants will have the opportunity to join this training session based on availability:
  - a. Session 1: Saturday, 18 November, 6.30am – 9.00am
  - b. Session 2: Saturday, 18 November, 9.00am –11.30am
- iii. Registration starts on 11 October 2023 until 27 October 2023 on [aia.com.my](http://aia.com.my).
- iv. This Event is open to 480 participants and registration is on a first-come-first-serve basis.
- v. There shall be no fees or charges imposed to participate in this Event.

**2. Eligibility**

- i. The Event is open to all Malaysians aged 7 to 13, including children of AIA Malaysia's permanent employees, contract staff and Life Planners ("Participant").
- ii. AIA Malaysia comprises AIA Bhd., AIA PUBLIC Takaful Bhd., AIA General Berhad, AIA Health Services Sdn. Bhd. and AIA Pension and Asset Management Sdn. Bhd.

**3. Event Terms Acceptance**

- i. Participants who wish to join the Event must register their details via [aia.com.my](http://aia.com.my).
- ii. Parent/legal guardian aged 18 and above will need to register the Participant and is allowed to register a maximum of 2 participants aged 7-13 for the Event using the same registration form.
- iii. Each Participant shall be entitled to a single-entry registration only. In the event of multiple submissions of registration by any of the Participant, the submissions shall be consolidated as one single-entry registration.
- iv. By registering for the Event, the Participant's parent/legal guardian also give his/her consent for the Organiser to receive and store his/her data and the Participant's data as reflected in the registration form. This is for the Organiser through its appointed event agency to verify the Participant's information on the Event day to allow him/her to enter the Event venue.
- v. The Organiser through its appointed event agency for this Event will send an Event email confirmation to the first eligible 480 Participants to confirm their spots for the Event via email address given by the Participants during registration, no later than 31 October 2023. The event confirmation will be sent to the Participant's parent or guardian's email address provided during registration. This email confirmation will serve as an entry ticket for each Participant for the Event.

- vi. If the selected training session is full, the Organiser may assign another training session to the Participant, subject to availability.
- vii. Participants are required to attend only their assigned session given by the Organiser and are prohibited from exchanging slots. Any attempt to do so will result in denied entry.
- viii. Participant is required to show the email confirmation from the Organiser which will serve as an entry ticket to the Event. Entry is strictly not permitted without the Organiser's valid email confirmation.
- ix. Entry ticket to the Event is non-transferable.
- x. The Organiser will not be held liable if the Participants cannot be contacted for whatever reason. In this situation, the Participant's eligibility for the Event will be forfeited and the Organiser reserves the right to select the next qualified Participant. The Organiser shall not be held responsible for any losses (including loss of opportunity and any other losses flowing therefrom) and damages suffered in the event the Participant cannot be contacted.
- xi. The selection of the participants of the Event shall be deemed final and conclusive under any circumstance and no complaint from any participants will be entertained. The decisions appointed by the Organiser are final, conclusive and binding and no further appeal, enquiry and/or correspondence will be entertained.
- xii. Participants aged between 7 to 13 years old are eligible for a complimentary Personal Accident insurance coverage during their participation in the Event, subject to the Organiser's sole discretion. The personal accident insurance will not cover participants who submit incomplete and false information and declaration during the registration of this Event. The Organiser reserves the right to reject and deny the Participants' claims.
- xiii. Participants' and their parent/legal guardian must confirm that they have read and understood and agreed to be bound by these Event Terms through the Participant's participation in the Event.
- xiv. By participating in the Event, Participants must fulfil all the terms and conditions. If discrepancies are found, the respective Participant's participation in the Event will automatically be forfeited and the next eligible Participant will be selected.

#### **4. Event Offerings**

The Participant is entitled to the following:

- i. One (1) entry to the Event, coaching session guided by Tottenham Hotspur Global Football Development Coaches as well as local Coaches;
- ii. One (1) exclusive football training kit (Kit). Participant is required to collect the Kit during registration on the event day, details of Kit collection will be shared with the Participant's parent/legal guardian. The Kit contains the following items:
  - i. Participant t-shirt and shorts – Participants are required to wear this t-shirt and shorts during the event
  - ii. Drawstring bag
  - iii. Notepad and pen
  - iv. Shin guard
  - v. Socks
- iii. The Organiser reserves the right to modify the items in the Kit and to adjust Participants' chosen t-shirt and shorts sizes based on availability.

- iv. Participate in any other on-ground activities hosted during the Event.

## **5. Exclusions /Indemnity**

- i. The Organiser and its affiliates, authorised dealers/distributors, agents or suppliers shall not be held liable for the following:
  - a. Any delay in performing or partial/total failure to perform any of its obligations to the Participants under this Event if such delay or failure is caused by circumstances beyond the reasonable control of the Organiser, its affiliates, authorised dealers/distributors, agents or suppliers, including without limitation delays, changes, disruptions, cancellations, diversions or substitutions howsoever caused including without limitation as a result of war, terrorist action or threatened terrorist action, strikes, hostilities, civil commotions, accidents, fire, flood or natural catastrophes; and
  - b. From any loss, damage to property, injury, contracted COVID-19, or death resulting from or related to the Participants' participation or inability to participate in this Event, or the use, misuse or inability to use the Kit and/or Prizes from the Event or any portion thereof.
- ii. The Participants forever waive, release and discharge the Organiser and its affiliates, authorised dealers/distributors, agents or suppliers from and against, any and all liabilities, costs, loss, damages or expenses which the Participant or any party claiming through the Participant hereafter may have arising out of acceptance of any Kit and/or Prizes or participation in the Event including (but not limited to) personal injury and damage to property and whether or not direct, consequential or foreseeable.
- iii. The Kit as well as prizes from any activities during the Event (Prizes) are given and accepted entirely at the risk of the Participants. Any Kit and/or Prize-related expenses, including tax liabilities (if any) in relation to Event shall be the sole responsibility of the Participants and/or Winners.
- iv. The selection of the Winners of the Event shall be deemed final and conclusive under any circumstance and no complaint from any participants will be entertained. The decisions appointed by the Organiser are final, conclusive and binding and no further appeal, enquiry and/or correspondence will be entertained.
- v. The Kit and/or Prizes are not exchangeable and/or transferable. Failure to accept a Kit and/or Prize by the Participants prior to the Event or at the Event when required to do so shall constitute a rejection by such Participant(s) and/or Winner(s) and the Organiser reserves its rights to award the Kit and/or Prize to another Participant (s) and/or Winner(s).

## **6. Unconditional Agreement**

- i. Acceptance towards attending the Event constitutes the Participants' unconditional agreement and permission to the Organiser to forever use the Participants' names, video footages, voices, photographs and/or likeness for purposes of advertising, editorial, promotional, marketing, trade and/or other purposes without further compensation and notice, unless prohibited by law. The Organiser reserves the right to such forms of publicity and publication.

## **7. Laws**

- i. This Event shall in all respect be governed by the laws of Malaysia. By entering this Event, the Participants agree to submit to the jurisdiction of the courts of Malaysia.

## **8. Modifications**

- i. The Organiser reserves the right to add, delete, vary or amend the terms and conditions herein or change or modify any aspect of this Event, in whole or in part at any time and from time to time and at its sole discretion without notice and without liability to the Participants or any other party. Without prejudice to the aforesaid, the Organiser reserves the right to cancel, terminate or suspend this Event at any time before with due notice but without any liability or compensation whatsoever. In the event of such cancellation, termination or suspension of this Event, the Organiser may at its sole and absolute discretion choose not to award the Kit and/or Prizes in respect of this Event to the Participants.

## **9. Cost**

- i. All costs incurred by the Participants in relation to and/or with respect to the Event including without limitation postal charges or Internet Service Provider (ISP) charges (if applicable), all transport costs, communication charges, accommodation, meal costs and other related costs incurred by the Participant as a result of and/or pursuant to his/her participation in the Event shall be solely borne by the Participant. The Organiser shall not be under any obligation to reimburse the Participant for any of such costs and expenses incurred thereof.

## **10. Miscellaneous**

- i. The Participants shall not be entitled to assign any of the rights or sub-contract any of the obligations herein. The Organiser shall be entitled to assign or sub-license the whole or any part of its rights hereunder to any third party as may be determined by the Organiser.
- ii. The invalidity, illegality or unenforceability of any terms hereunder shall not affect or impair the continuation in force of the remainder of the Terms and Conditions of the Event.
